Notice Regarding Organizational Changes, Executive Officer and Personnel Changes at the Department Head Level and Above

We would like to announce that we have decided on organizational changes, executive officer and personnel changes at the department head level and above as follows today.

- 1. Organizational Changes (Effective January 1, 2025)
- Partial abolition of the block system and introduction of an independent division system in the three major metropolitan areas

The Company has previously adopted a block system by dividing Japan into six blocks to clarify responsibilities and authority, thereby achieving rapid decision-making. Under this system, each block manager was responsible for overall activities within the region, including construction and sales activities, recruitment, and strengthening relationships with certified contractors.

However, in the so-called three major metropolitan areas of Tokyo, Osaka, and Nagoya, the market size is large, and there are many redevelopment projects, requiring a high level of expertise. Therefore, we have determined that it is necessary to increase the allocation of management resources to the Buildings Division and establish specialized systems for both the Housing Division and the Buildings Division.

In response, we will reorganize the Kanto Block, Hokushinetsu Block, Chubu-Kansai Block, and Construction Business Department, and newly establish the Construction Project Management Division, Buildings Division, and Housing Division.
