
Highlights

In the interview, Mr. Sakurai offers insights based on his extensive experience as a market analyst and commentator, probing into Nippon Aqua's business environment, financial performance, shareholder returns, and medium- to long-term strategic direction. President Nakamura responds to each point in a clear Q&A format.

Key topics include:

- ✓The strong performance of the detached housing segment, which drove company-wide growth despite sluggish new housing starts.
- ✓ Future prospects for the building construction and waterproofing divisions.
- ✓The company's efforts to increase the number of skilled applicators despite ongoing labor shortages—an issue of particular interest to investors.

Mr. Sakurai and President Nakamura have held discussions at several key moments in the company's history, including prior to Nippon Aqua's 2013 listing on the Tokyo Stock Exchange Mothers market and its 2018 listing on the First Section, making this a dialogue between long-time acquaintances.
